This emulsion provides gloss and holdout in flexo and gravure formulations for paper and paperboard inks and overprint varnish applications. As a modifier, it also contributes to improved dry speed.

Joncryl ECO 2189 is recommended for applications such as:

- · Printing inks for flexographic or gravure applications
- · Overprint varnishes for packaging, commercial, or publication applications

These polymers provide an 80% reduction in VOC compared to conventional water-based polymers.
