Rheovis® PU 1193 provides optimum performance in aqueous clear and high-gloss top coatings as well as anti-corrosive paints and thick-layer systems.

## Formulation guideline

0.2 - 1.0% on total formulation

Rheovis® PU 1193 can be incorporated directly into the paint or the mill base during stirring. As highly efficient rheology modifier Rheovis® PU 1193 should be added slowly to the formulation and adequate mixing times should be applied.

## **Storage**

Keep container tightly closed and dry; store in a cool place.
